Teaching Canadians to save themselves and rescue others

Annually, over 1.2 million Canadians participate in our swimming, lifesaving, lifeguard, first aid and leadership programs. Each year, we certify thousands of instructors who provide the leadership for our training programs. Over 30,000 Canadians earn our Bronze Medallion each year. As Canada's lifeguarding experts, we set the standard for lifeguard training and certify Canada's National Lifeguards.

Making Canadians Water Smart®

The Lifesaving Society focuses Water Smart drowning prevention efforts on people most at risk – like men fishing in small boats – or on those who can make a significant difference, such as parents of young children. We deliver Water Smart messages through our swim program, through the media and community action. Our Swim to Survive® program provides the essential minimum skills required to survive an unexpected fall into deep water.

Drowning research

The Lifesaving Society conducts research into fatal and non-fatal drowning, aquatic injury and rescue interventions. Ongoing research and analysis supports the Society's evidence-based water-rescue training and Water Smart drowning prevention education.

Setting the standard

The Lifesaving Society establishes aquatic safety standards and consults on aquatic safety issues for the aquatic industry, governments and the judiciary. The Society offers a suite of services to help aquatic facility operators maintain and improve safe pool and waterfront operations. We perform aquatic safety audits and serve as experts in legal cases involving aquatic safety.

Lifesaving sport

The Lifesaving Society is the Canadian governing body for lifesaving sport – a sport recognized by the International Olympic Committee and the Commonwealth Games Federation. We use lifesaving sport to engage and inspire youth in our drowning prevention mission. Our Lifesaving Sport Fundamentals program offers a recreational introduction to lifesaving sport skills. Age-group, senior and masters athletes compete regionally, provincially, nationally and internationally. We offer certification programs for officials and coaches.

The Lifesaving Society

The Lifesaving Society is a full-service provider of programs, products and services designed to prevent drowning. We save lives and prevent water-related injury through our training programs, Water Smart public education, drowning research, aquatic safety management and lifesaving sport.

We are a national volunteer organization and registered charity composed of ten provincial/territorial branches, tens of thousands of individual members, and over 4,000 affiliated swimming pools, waterfronts, schools and clubs.

The Lifesaving Society is a leader and partner in the delivery of water safety education throughout Canada and around the world. (The Society operates globally in over 25 countries.) We represent Canada in the Commonwealth Royal Life Saving Society and we are Canada's Full Member in the International Life Saving Federation. The Lifesaving Society takes lead responsibility for drowning prevention in Canada.

We have been teaching swimming, water safety and water rescue in Canada since 1896. Established in England (1891) as The Swimmers' Life Saving Society, we became The Royal Life Saving Society in 1904. Today, we are known as simply the Lifesaving Society.

*Lifesaving Society, Water Smart, Swim to Survive, Swim for Life and National Lifeguard Service are all registered trademarks of the Royal Life Saving Society Canada.

PRESIDENT'S REPORT

"Take your mark. GO!" – an apt metaphor for the Society's dynamic team effort in 2023.

"Take your mark. GO!" could easily be Lifesaving Sport's mantra. Love of sport by athletes, clubs, coaches, officials and volunteers swept the province in 2023. With leadership from our Lifesaving Sport Council, competitions were resurgent with generous hosts extending welcoming sport environments. They included the University of Waterloo, Oakville, Markham, Saugeen Shores, Orillia, McMaster University and Aurora. Windsor [full disclosure, my adopted hometown and employer], hosted both the 2023 Canadian Pool Lifesaving Championships and RLSS Commonwealth Lifesaving Championships. I thank our local organizing committee and adjacent municipalities for putting on these spectacular events. It was our honour to host hundreds of dedicated Canadian and Commonwealth lifesavers and volunteer officials.

"Train to win" is a fitting way to describe the depth of work produced by our Training Programs team in 2023. With the close of the 18-month Swim Transition period mid-year, Training Programs now supports thousands of new Swim Instructors, 165 year-round Swim Program Licensees and many more seasonal ones. With an Awards Report showing a return to pre-pandemic levels, Training Programs can proudly celebrate 2023 as a new highwater mark for certifications in Ontario. It is heartening to see the Bronze medal awards so healthy: Medallion and Cross are up 30% and 26% respectively over 2019's record numbers. National Lifeguard certifications are 23% higher than the previous high in 2019. Instructor certifications climbed 24% higher than the 2019 record!

Our Leadership team members were involved in a race of their own in 2023! Applause please for the volunteer/staff team who drove the revision of the Society's leadership recertification system to the finish line – bringing this years-long project to fruition. Huge kudos to this talented and innovative group for their expert support of those who teach the Society's programs throughout Ontario. Our Public Education team were buoyed by the news in November that the Ontario Ministry of Education was renewing its significant financial support for the Society's Swim to Survive school grant program for the 2023/2024 school year. This meant the Society could continue to reach Ontario's Grade 3 students with the basic skills needed to survive an unexpected fall into deep water. In addition, 2023 saw strong media outreach for Water Smart education as well as positive interim data suggesting a decrease in drowning incidents compared to 2022 – the reason why we're all here!

In their own lanes, our Management Training team of professionals put in a solid performance to deliver forward-thinking services and supports for aquatic managers and facility operators and owners. Their Safety Standards colleagues continued important research on the lingering impacts of Covid, developed audit and incident management resources, updated regulatory resources and published analyses of court and inquest findings.

Every winning team relies on a solid support team. Member Services (comprising both Area Services and Member Services Councils), maintains our corporate functions and provides support to the Society's volunteer leaders on the Ontario Board of Directors, Council of Officers, Activity Centre Councils, as well as our Area Chairs who represent 38 regions across the province. Our information services and communications departments once again provided the backroom backbone of our corporate enterprise.

Speaking of support teams, Fundraising produced a 23% increase in their Water Smart[®] and Swim to Survive[®] campaigns in 2023. These community fundraising initiatives



directly support the Society's drowning prevention mission and provide Affiliate Members with opportunities to engage their communities with lifesaving water safety information. Our thanks to those who hosted events, to their volunteers and to the donors.

In addition to the amazing work done by our Activity Centre Councils, eight representatives from Ontario travelled across the world to attend the 2023 ILS World Conference on Drowning in Perth, Australia, joining others from over 50 countries. We look forward to benefiting from your experience and those global drowning prevention strategy discussions.

Some final kudos and thanks: To Lifesaving Society Ontario staff members – a heartfelt thanks for your dedication, creativity, commitment and support. It is very much appreciated.

I would also like to acknowledge and thank the Honourable Elizabeth Dowdeswell for her honorary patronage as Lieutenant Governor from 2014–2023. A selfless and stellar volunteer in her own right.

Finally, to all the Society's many volunteers, I look forward to you "taking your mark" this upcoming year, and to seeing where we all "go" in 2024.

TREASURER'S REPORT

The summary financial information presented here is derived from the Royal Life Saving Society Canada, Ontario Branch ("the Society") audited consolidated statements for the year ended December 31, 2023. These include the results of the Drowning Prevention Research Centre Canada, a federally incorporated registered charity controlled by the Society. Detailed audited consolidated financial statements of the Royal Life Saving Society Canada, Ontario Branch are available upon request.

The Society achieved net revenue of \$11.50 million in 2023, surpassing expenditures of \$10.29 million thereby generating a surplus of \$1.21 million in contrast to a deficit of \$1.23 million recorded in 2022. This improvement can be attributed to the growth across all core revenue streams, with several benefiting from new affiliates following the Swim Transition from the Canadian Red Cross, coupled with robust investment income.

Water Rescue experienced substantial growth in 2023, registering net revenues of \$4.24 million, marking a notable increase from \$2.96 million in the prior year, primarily driven by expansion in Training Programs and increased Swim licenses through the acquisition of new affiliates after the Swim Transition.

Literature continued its steady growth in 2023, with net revenue reaching \$2.50 million compared to \$2.17 million in 2022. This growth was driven by increased sales of the *Canadian Lifesaving Manual* and *Canadian First Aid Manual*, reflecting the continued demand for training materials both in Ontario and other Lifesaving Society Branches.

Leadership demonstrated substantial growth in 2023, with revenue reaching \$1.10 million compared to \$0.54 million in 2022. This significant increase can be attributed to the resumption of leadership courses, particularly in Toronto and Ottawa, and the addition of new Instructors and Trainers from the Swim Transition initiative. Lifesaving Sport experienced significant growth in 2023 with net revenues of \$245,000, which were up from \$31,000 in 2022 given the successful year for competitions, notably hosting the Commonwealth Lifesaving Championships, Canadian Surf, Ontario Senior & Junior Lifeguard Games, and Canadian Pool Lifesaving Championships.

Other income sources increased significantly in 2023. Investment income was \$858,000, up from negative \$812,000 in 2022, given the strong investment return of 16% and the investment balance remained strong at \$6.3 million at year-end including high-interest savings (2022 \$5.4 million). Also, Swim to Survive grants utilized were \$1.17 million, up notably from \$450,000 in 2022.

Expenditures in 2023 totalled \$10.3 million, representing an increase of \$2.5 million compared to the same period in 2022, including higher Swim to Survive claims, which were offset in grant revenues. Other increases were primarily from items that get allocated across the programs, including salaries and benefits, and administrative costs such as shipping and meetings, and

reflected inflation and heightened activity levels. Lifesaving Sport expenses also saw an uptick in 2023, predominantly due to the Commonwealth championships, albeit offset by higher related revenues.

The Society's financial performance in 2023 was robust, characterized by significant revenue growth across various programs and prudent expense management. A transfer of \$225,000 to the capital fund in 2023 was executed to support the replacement of capital assets, including new office and warehouse infrastructure, positioning the Society for sustained success in advancing its mission of preventing drowning and reducing waterrelated injury in the ensuing years.

TRAINING PROGRAMS

Training Programs contributes to the mission of the Society by developing and supporting the delivery of training programs and related education products and services to prevent drowning and water-related injury and to train Ontarians how to swim and to rescue themselves and others in, on or around the water.

First aid test and program analysis

In 2023, to eliminate ambiguity, the First Aid Committee revised a few questions on the written EFA and SFA tests. Revisions to first aid resources continue and will be shared on the Lifesaving Society website in due course. The committee is also conducting an analysis of two potential new first aid programs.

Lifeguard 4 Life podcast

In 2023, **Juanita Bueschleb** joined producer **Patrick King** and hosts **Stephanie Bakalar** and **Jason Jolicoeur** to discuss the Society's new Aquatic Supervisor and Aquatic Manager certifications. Podcasts are available on the Lifesaving Society YouTube channel, Anchor, Apple, Google and Spotify.

Literature review

Thank you to Training Programs Council members **Ashley Hutchison** and **Adrian Wong** who reviewed technical resources and provided invaluable feedback using both their aquatic and educational expertise.

Lifeguard Services Committee


Virtual round-tables

To increase engagement with instructors delivering the National Lifeguard program, Lifeguard Services Committee members led by **Adrian Wong** and moderated by **Marek Holke**, delivered two round-table discussions via Zoom in 2023:

Spinal injuries: The term "immobilization" has given way to "spinal motion restriction." This discussion featured **Scott Ruddle** in conversation with National Lifeguard Instructors about the meaning of spinal motion restriction, how it differs from immobilization, strategies and techniques on training lifeguards, and more.

Single guard situations: "Single Lifeguard Situation" is a stand-alone evaluation item in the revised National Lifeguard program. This discussion featured **Shelley Makepeace** talking with National Lifeguard Instructors about single lifeguard emergency procedures and training strategies that help prepare lifeguards for real-life situations.

Over 100 people attended the live sessions and hundreds more viewed the posted recordings on the Society's website.



New Pool Attendant

In 2023, the Society revised, renamed and launched the new Pool Attendant certification designed to provide lifesavers with the knowledge and skill to supervise wading pools, splashpads, waterslides and amusement devices. The new Pool Attendant certification supersedes the now retired Wading Pool Attendant.

A series of virtual information sessions were hosted for Area Chairs, Affiliates and Instructors on the new program. These sessions were recorded and posted on the Society's website. Thanks go to Aquatic Proficiency Chair **Allison Courtney** for her work in revising and launching the program.

Resource development

The Resource Development Committee members **Wasi Rizvi**, **Carolyn Reinhart**, **Isha Maharaj** and **Sweeny Rose Esperanza** collaborated with the Bronze Family Committee to create a Bronze report card to help examiners evaluate and provide feedback to candidates. The report card is available on the Society's website.

In a collaboration with the Swim Committee, **Isha Maharaj** and **Sager Maharaj** used their equipment, photography and editing skills to capture images of learn-to-swim progressions for the Swim Licensee Dropbox of resources.

We thank the Town of Caledon (Southfields Community Centre pool), Resource Development Chair **Megan Mintz**, **Andrew Mintz** and our young volunteer actors: **Alex** (age 4) and **Emma** (age 2). These images are being used in current projects underway.

This summer's launch of the Society's Water Smart Parents campaign made use of the many resources, photos, videos, activities and ideas submitted from Resource Development Committee members **Dawson Parke**, **Sylvia Pearson** and **Megan Mintz** (and family).

Swim for Life

The Swim Committee had a busy year supporting both existing and new Swim Licensees including 77% more year-round licensees than in 2022.

The committee hosted four virtual Swim meetings with over 400 participants. These meetings allow affiliates to share ideas, network with other Swim affiliates and generate ideas for new resources that the committee will develop in 2024.

New resources were added to the Swim Licensee Dropbox including a new index to assist affiliates in finding things in the Dropbox more efficiently.

WWRAC presentations

In Kitchener in May, Lifeguard Services Chair **Adrian Wong** with **Elyse Laughton** and **Sarah Laughton** (Swim Committee members) led an in-water training session called "Let's Go Back to Basics" for leadership personnel who train aquatic staff.

Lifesaving Society Program Manager **Marek Holke** facilitated the ever-popular First Aid and National Lifeguard "Myth Buster" session at the June WWRAC Symposium in the Township of Wilmot.

Waterpark Attendant project

In 2023, the Society collaborated with waterpark operators in the development and launch of the Waterpark Attendant certification course.

LEADERSHIP

The Leadership Activity Centre contributes to the Society's mission by developing the instructors, coaches, examiners and trainers who teach Ontarians how to swim, how to rescue, and how to be safe in, on and around the water. Leadership supports the mandates of Training Programs, Lifesaving Sport, Safety Standards, Management Training, Public Education and Area Services.

This passionate group is lead by Leadership vice president Kerry Wakefield and chairs Elisabeth Drouillard, Jason Jolicoeur, Charlene Pugh, Tiffany Vis and Tamara Wood.

Teaching online

Leadership Council members led three virtual and interactive sessions during May and June that focused on key concepts involved in teaching in blended or completely online formats. The target audience were trainers who teach Swim and Lifesaving Instructors, but also included Assistant Instructors, Examiners and First Aid Instructors. Thank you to **Tamara Wood** who developed the session.

Leadership recertification revamp

In 2023, the Leadership Council finished revamping the leadership recertification system and finalized the associated support pieces needed. We thank them – and everyone they tapped on the shoulder – for their hard work and patience. The exciting fruit of their efforts will be unveiled in 2024.

Literature review

Thank you to **Jason Jolicoeur** and **Tiffany Vis** who brought valuable aquatic and educational expertise to their review of draft training program resources that are in development.

National trainer reappointments

In April, the Lifesaving Society reappointed 35 national trainers for two-year terms. National trainers are experienced and talented trainers who play a key leadership role in the development of instructor trainers across the province.

OTAS program revised

The Ontario Teachers' Aquatic Standard (OTAS) program is designed for secondary school teachers to introduce basic swimming skills, drills and progressions to students at indoor school pools. The newly revised program was launched in September with great success following a pilot (January through June 2023) by nine Ontario high schools involving 122 secondary school teachers. Extended Swim Transition

To maximize the number of certified instructors available to provide swim lessons across Canada, the Lifesaving Society extended the 2022 Swim Transition period through June 30, 2023, keeping open the special pathways that facilitate the transition of Red Cross water safety instructors and trainers to Lifesaving Society certifications.

Thank you to **Kerry Wakefield** who conducted one final online Swim Transition Trainer Course in May for those across the country who had yet to transition.

Examiner mentor workshop

Kerry Wakefield, joined by Area Chair **Marta Wrzal**, presented "Become an Examiner Mentor" at the York Region Aquatic Council's May "Spring Thing" workshop at Vellore Village in Vaughan. For experienced instructors who wanted to become an examiner mentor, Kerry and Marta presented an overview of the Society's examiner mentor process. Discussion included challenges that organizations are facing and some potential solutions to support staff.

Quality assurance and certification review

The integrity of the Society's training programs depends upon maintenance of its certification standards. In 2023, a plethora of written complaints about standards, program delivery and the conduct of members and volunteers, triggered three full investigations by the Certification Review Committee. These investigations resulted in sanctions, temporary suspensions, revocations or decertification for offences.

Thank you to Corporate Secretary **Stas Bodrov** for his leadership and to all the volunteers who participated as Certification Review Committee members in 2023.

MANAGEMENT TRAINING

Management Training contributes to the mission of the Society by providing training and certification opportunities for leadership personnel who help aquatic facility owners, managers and operators prevent drowning and water-related incidents.

Paul Di Salvo, VP Management Training, guided the Society's Management Training Council through many exciting projects in 2023.

Professional development

Minnie Fisher, Professional Development Chair, ensured the successful delivery of Lifesaving Society sessions at the 2023 PRO Aquatic Conference. Minnie also planned and hosted the Society's "Canadian Symposium on the Use of Emerging Technology in Aquatic Safety Supervision" in Toronto in October. Delegates and speakers from around the world participated in person or online in this exciting day long event.

Aquatic management training

Jerry Lynch, Management Training Chair, oversaw the official launch and promotion of the Society's new Aquatic Supervisor and Aquatic Manager programs. Jerry provided input into the development of program support materials and update clinics for trainers and instructors. Success was clearly evident in the quick uptake of the revised programs.

Jerry also served as the final certifier of safety management leadership personnel who apprenticed in 2023.

Pool operations


David Pignataro, Pool Operations Chair, continued work on the revision of the Society's Pool Operator programs in preparation for the development of new leadership materials in 2024. A survey was conducted seeking input to these revisions and Management Training Council discussions occurred. Efforts now turn to the development of the necessary resources with the help of the Leadership Council.

Management proficiency

Salman Siddiqui, Management Proficiency Chair, focused on a review of the Lifesaving Society Staff Shortage Report from 2018. With Salman's direction, a survey was conducted seeking to update the report and provide new resources to affiliates to help with staff retention and hiring.

Webinar

Nikolay Nikolov, Webinar Chair, researched topics for Lifesaving Society-hosted webinars. In 2023, he hosted webinars on topics that assisted pool operators in the management of safe aquatic facilities.



SAFETY STANDARDS

Safety Standards contributes to the mission of the Society by setting and clarifying standards and by providing tools that help pool and waterfront owners, managers and operators prevent drowning and maximize public safety.

Gary Sanger, VP Safety Standards, worked with Safety Standards Council Chairs in the development and delivery of many initiatives throughout 2023.

Research partnerships

Nathalie V Martin, Research Chair, continued research throughout the year with Society partners Toronto Metropolitan University, University of Windsor and Conestoga College. These are the Ontario post-secondary institutions that provide certification for public health inspectors.

Research topics in 2023 included the impact of the Covid protocols and an Analysis of Health and Safety Audits of Aquatic Facilities in Ontario: 2002–2020. Preparatory work was started on new projects for 2024.

Audit services

In 2023, the Lifesaving Society completed 12 safety audits of Ontario swimming pools and waterfronts.

Lisa Adams, Safety Audit Services Chair, continued development work on an aquatic industry safety awards program and updating audit resources for 2023. In addition, Lisa developed materials for the promotion of safety audits at the 2023 PRO Aquatics Conference exhibit session. She also coordinated revisions to the SEE audit checklists.

Guide to public pools regulation

With her committee members, **Janice Carroll**, Regulation Review Chair, revised the Society's *Guide to Ontario Public Pools Regulation* required to reflect changes in Regulation 565. The committee also began work on the development of new waterslide standards.

Standards online

Sean Duffy, Standards Chair, worked to move Lifesaving Society Ontario standards online. The Society's website - lifesavingsociety.com - now features nine standards. An additional 12 standards will be posted in 2024.

Sean also continued to update Covid-related resources for aquatic personnel. These guidelines are instrumental in the safe management of aquatic facilities.

National Safety Standards Commission

Sean Duffy joined the Lifesaving Society National Standards Commission representing Ontario. With his help and guidance, several new standards were developed and published on the Society's national website.

In October, Lifesaving Society Ontario hosted the in-person meeting of the National Safety Standards Commission.

Incident management resources


Teresa Taylor, Incident Management Chair, revised existing online incident management resources for pool operators so that they can more effectively plan for and manage major incidents. She also continued her research on critical incident stress and the development of related support resources for aquatic staff.

Court and inquest

Rob Richardson joined the Safety Standards Council in 2023 as Court and Inquest Chair. He was quick out of the gate by selecting a 2016 inquest inquiry in Australia. He conducted research, developed a draft report and shared it for comment. This report entitled *Yeoman Inquiry* focused on a diving injury at a public pool. The final report will be published on the Lifesaving Society Ontario website in 2024.

Expert witness

In 2023, the Lifesaving Society was retained as an expert in seven cases to assist law firms in reviewing incidents in aquatic settings in Ontario, Quebec, Alberta and Prince Edward Island.



LIFESAVING SPORT

Lifesaving sport is the only sport whose skills are first learned for humanitarian purposes. Through lifesaving sport, the Lifesaving Society seeks to engage and inspire youth in our drowning prevention mission.

Curtailed by the Covid pandemic since 2020, Lifesaving Sport roared back to life in Ontario in 2023. By the numbers:

Sanctioned regional competitions.

Provincial championships with 593 competitors representing 25 clubs.

TeleGames with 643 participants from 15 clubs.

Canadian championship with 175 athletes from 18 clubs.

Commonwealth championship with over 150 athletes and 150 international volunteers and officials.

1 International Surf Rescue Challenge in Texas with 6 Ontario athletes and coaches.

Ontario championships

Thirty-five Ontario championship records were set in 2023 pool competitions including nine Senior Lifesaving, 10 Masters and 16 Junior Lifesaving.

In February, 13 teams with 44 competitors from four clubs competed in the **Ontario Lifeguard Championships**. We thank **Colin Cabral** and **University of Waterloo** volunteers and staff for being such wonderful hosts.

In March, 89 Senior and 23 Masters competitors from 11 clubs competed in the **Senior & Masters Lifesaving Pool Championships**. We thank **Justin Cordivani** and **Town of Oakville** volunteers and staff for hosting this successful event.

The June **Ontario Junior Lifesaving Championships – Pool** was our biggest event of the season with 314 junior competitors from 19 clubs. **Jeff McCurdy** and **City of Markham** volunteers and staff rose to the challenge posed by the size of the event.

The provincial championship season wrapped up in August with the **Ontario Lifesaving Championships – Waterfront** with 121 competitors (48 Junior, 7 Masters, 66 Senior) from 11 clubs who enjoyed three days of competition on the shores of Lake Huron. **Michael Hundt, Saugeen Shores Lifesaving Club** and the **Town of Saugeen Shores** volunteers and staff hosted an outstanding and dynamic event.

Sanctioned events

PUBLIC EDUCATION

Public Education contributes to the mission of the Society by increasing awareness of the risks associated with activities in, on and around water. The aim is to modify Ontarians' at-risk behaviour to eliminate drowning and water-related injury.

School grant program

The Society approved applications for 73,624 Grade 3 students and 19,872 Grade 7 students for Swim to Survive and Swim to Survive+ training respectively for the 2022/23 school year.

The school grant programs would not be possible without the generous support of the **Ontario Ministry of Education** since 2006. In November 2023, the Ministry confirmed a grant of \$1.76 million to support the Society's school grant program through the 2023/2024 school year.

Special thanks to **Jillian Hamilton** for her guidance and assistance as part of the Application Approval Committee. The Society greatly appreciates the long-standing and continuing support of **PPL Aquatic, Fitness and Spa Group** for the Swim to Survive and Swim to Survive+ programs.

In 2023, the Swim to Survive Committee, led by chair **Sydney Shelp**, completed a draft teaching resource for Swim to Survive+ for review by school grant program users.

New Canadian outreach

In 2023, the Lifesaving Society developed a New Canadian Outreach program that provides tools to Society affiliates and partners to help them deliver water safety messages to people new to Canada. This initiative also encourages affiliates and partners to offer Swim to Survive and Family Swim to Survive opportunities.

Affiliates in four provinces and the NWT joined 69 Ontario affiliates, partners and organizations in this initiative, which included the distribution of 154,500 Water Smart Tip Cards in multiple languages and 10,000 StartBoating.ca promo cards.

National Drowning Prevention Week

The Lifesaving Society designates the third week in July as National Drowning Prevention Week (NDPW) to focus community and media attention on the drowning issue and drowning prevention. In 2023, the Communications team led a successful campaign to support parents in protecting their children in and around water. The Water Smart[®] Parents campaign featured a new website and accompanying social media and media relations campaign.



Anyone can drown, no one should.

The UN General Assembly Resolution on Global Drowning Prevention designated July 25 as World Drowning Prevention Day to be observed globally every year. Activities in Canada varied by province and social media channels were the primary messaging vehicle. Lifesaving Society Ontario shared media posts.

Water Smart contest

Research


The Lifesaving Society reports on drowning and unintentional water-related deaths. These reports provide a comprehensive fact base to guide the Society and others in developing effective drowning prevention solutions.

Water-related death data for Canadian provinces and territories is extracted from the Offices of Chief Coroners and Medical Examiners by the Drowning Prevention Research Centre Canada (DPRC) – the lead agency for drowning and water-incident research in Canada.

Fatal drowning

In 2023, the Lifesaving Society published infographic reports for Ontario, Manitoba, the Maritimes and Newfoundland and Labrador using data from 2010 to 2019. Due to delays in data collection in some provinces and territories caused by Covid-19, the Society was unable to produce a 2023 national drowning report.

The Society also produced weekly preliminary data reports from May to September, based on media releases, news reports and internet searches. Tracking preliminary data is an important first step in understanding fatal drowning trends in any given year. Interim data is verified and included in the coroner data collection process once coroner data becomes available.



Interim data

Interim data for Ontario indicated a possible decrease in drowning incidents (-13%) compared to 2022. An increase in media reports involving bathing and non-aquatic activity (combined increase of +67%) was offset by a decrease in reports involving aquatic activities (-18%), boating (-27%) and land, ice or air transportation (-50%).

In Ontario, more drownings among children under 5 years were reported than in previous years, and the number of media reports involving young adults 15–24 years increased (+80%). However, there were noticeable decreases (-71%) in reported drownings among adults 30–39 years.

By comparison, interim data for Canada as a whole indicated a slight overall decrease in fatal drownings (-3%). Increases in reported drownings in Nova Scotia (+57%), British Columbia (+21%) and Quebec (+13%) were offset by decreases in Alberta (-46%), Newfoundland and Labrador (-44%), Saskatchewan (-60%), and Ontario (-13%). Reported boating fatalities (+3%) and private pool fatalities (+18%) increased.

Non-fatal drowning

For every fatal drowning in Ontario, there are nearly four nonfatal drownings serious enough to require a visit to a hospital emergency department. This was one of the key findings of a research study conducted for the Lifesaving Society Ontario by the Drowning Prevention Research Centre Canada with Public Health Ontario.

The study, *Ontario Non-Fatal Drowning Report, 2023 Edition*, reported on 5,684 drowning-related emergency department visits over the ten-year period 2012–2021 (an average of 568 per year).

For 2021, the most recent year for which full data was available, the rate of visits increased to 4.3 per 100,000 population (641 visits) versus 4.0 in 2020 (568 visits). During the 2012–2021 period, 996 patients were hospitalized after being transferred from an emergency department due to non-fatal drowning (an average of 100 per year).





The Ontario Non-Fatal Drowning Report, 2023 Edition provides new information on non-fatal drowning by including information on the location of incidents. Overall, emergency department visits due to non-fatal drowning were most frequently associated with boating. Non-fatal drowning that resulted in hospitalization most frequently occurred in pools.

Non-fatal drowning rates were highest among children and youth. This differs from fatal drowning trends in Ontario where rates are highest among older people.

Males accounted for approximately two-thirds of non-fatal drownings. This differs from fatal drowning where males account for close to 80%.

Non-fatal drowning definition

Non-fatal drowning can result in costly hospital stays and longterm health problems. Information on non-fatal drowning is key to understanding the true extent of the drowning problem in Canada. To adequately capture this information, researchers identified a need for clarification of the term "non-fatal drowning" and a universal system for categorizing it.

In 2023, DPRC researchers worked with other international experts to finalize a categorization framework for non-fatal drowning based on the feedback from those who piloted the draft framework. The revised framework was presented at the International Life Saving Federation World Conference on Drowning Prevention in December.

Mapping boating-related drowning incidents

Work continued with the DPRC on an innovative threeyear Transport Canada-funded boating safety project to map boating-related incidents in three recreational boating communities in Quebec, Ontario and British Columbia. In 2023, incident data was collected from May–September and analysis began in October. The final report will be submitted to Transport Canada in 2024.

World Conference on Drowning Prevention

Ontario was well represented at the 2023 ILS World Conference on Drowning Prevention in Perth, Australia, December 5–7. **Barbara Byers, Tessa Clemens, Lisa Hanson Ouellette, Jason Jolicoeur, Becky Lehman, Eric Shendelman, Perry Smith**, and **Kerry Wakefield** were among 750 representatives from over 50 countries. The conference focused on shaping a global drowning prevention strategy and mobilizing for local action.

MEMBER SERVICES

Member Services develops and maintains the corporate functions, systems and infrastructure required to support and service the membership of the Society.

Governance

The National Society (Lifesaving Society Canada) is governed by a volunteer Board of Directors nominated by provincial/territorial branches and elected at the Society's annual general meeting by 10 Branch Representatives. National commissions are led by volunteer commissioners who report to the Board of Directors. These commissions are: Training Programs, Public Education, Lifesaving Sport, Safety Standards and International Relations. A national management team is comprised of senior staff of the 10 branches.

Lifesaving Society Ontario is governed by an elected volunteer Board of Directors with a volunteer Council of Officers and nine activity centre councils composed of professionals in recreation, education, business, finance, management and the medical and legal professions.

Ontario Board of Directors

The Board of Directors governs the Lifesaving Society Ontario in accordance with its mission and bylaws. Directors are elected for a two-year term by the Society's membership at the annual general meeting. No person or body external to the Societv is entitled to appoint any directors. Directors appoint all officers, including council and area chairs, and approve activity centre plans.

In April, President-elect Jennifer Knights replaced Kathleen Finn who stepped down as President.

Ontario Council of Officers

The Council of Officers is composed of two representatives of each activity centre council, the president as chair and the president-elect. Members of the Council of Officers are nominated by the respective activity centre council and appointed by the Board of Directors for two-year terms.

The Council of Officers represents active, affiliate and award members; manages topics not assigned to a single activity centre (e.g., governance review) or topics that are the responsibility of multiple activity centre councils (e.g., affiliate recognition review); and monitors the work of the Board of Directors. Any member of the Society may attend and speak at meetings of the Council of Officers.

Activity Centre Councils

Lifesaving Society Ontario organizes its drowning prevention work in activity centres: Training Program, Leadership, Public Education, Safety Standards, Management Training, Lifesaving Sport, Fundraising, Member Services and Area Services.

Activity centre councils are chaired by the topical vice-president or an individual appointed by the board. Councils are composed of portfolio chairs (appointed by the board for a two-year term) who oversee specific portfolios necessary to manage the work of the activity centre. Chairs recruit and develop committee members.

Any member of the Society may attend and speak at activity centre council meetings.

On the Lifesaving Sport Council, **Ellie Scholtzhauer** was appointed Athlete Rep in June. **Leslie Aziz** moved from Development Chair to Outreach Chair in November. The Chair without Portfolio position was retired.

On the Training Programs Council, **Ashley Hutchison** was appointed Bronze Chair in June replacing **Jason Jolicoeur** who took up an appointment as Chair on the Leadership Council.

On the Member Services Council, **Alberto Berumen** was appointed Volunteer Personnel Chair in January.

Members of activity centre councils are listed on the inside back cover. The Society's CEO is an ex-officio member of the Board of Directors and Council of Officers. Senior Officers and staff Directors are ex-officio members of their corresponding activity centre councils.

Area Services Council

The Area Services Council provides support services for Area Chairs, their volunteer personnel, and the individual members who support community delivery of drowning prevention activity. The VP Member Services chairs the council, which is comprised of the Area Services Chair and five Regional Representatives elected by area chairs.

Area Chairs

The Board of Directors appoints chairs to represent the Society in designated geographic areas (see inside back cover). These volunteer area chairs operate in 38 regions of Ontario. Area chairs recruit volunteer committee members and field representatives to help serve the area.

The Society appointed new area chairs in 2023. In January, **Colton Maracle** became co-Chair for Huron-Perth replacing **Amy Crawford**. **Nicole Wilson** became co-Chair in Toronto/ North York replacing **Mary Elmaassarany**.

In May, **Marilyne Jones** was appointed co-Chair for Grey-Bruce, succeeding **Bert Lennox**. **Kim Durant** became co-Chair for Lanark, Leeds & Grenville and **Adriana Pires** became co-Chair for Toronto/Etobicoke. Both resigned in November.

In June, **Nicholas Hay** was appointed co-Chair for Chatham Kent.

In November, Nicola Taccone was appointed co-Chair for Oakville succeeding Jonathan Brooker. Tara Quesnel succeeded Lori Gibeau as Area Chair for Cornwall. Mackenzie Cameron resigned as co-Chair for Peterborough-Northumberland-Hastings. Anthony Duong was appointed Area Chair for Sudbury-Manitoulin succeeding Kirk McGee and Laura Tagliafierro.

Training and development in the Caribbean

In 2023, the Society sent trainers to Antigua, Cayman Islands, Grenada, Turks and Caicos and Jamaica on behalf of Lifesaving Society Canada's International Development Assistance program. The Society is currently working with 11 Caribbean nations to develop self-sufficiency in survival swimming, lifesaving, lifeguard and leadership programs, and to build sustainable lifesaving organizations.

Information and communication services

Information Services continued to support Ontario and other provincial branch staff, while creating and improving upon the digital amenities the Society offers to its members. Communications services and Information services staff work closely together to serve the needs of the Society's individual and affiliate members through a variety of channels. Of note in 2023, we:

- Published four issues of *Lifeliner* for 163,000 subscribers.
- Distributed 29 direct email campaigns to members.
- Completed the transfer of Red Cross Training Partner and member data through the Swim Transition program, and provided continuous development and support to the online Swim Transition Instructor Clinic.
- Developed and launched a Commonwealth Lifesaving Championships website for international coaches and competitors attending the RLSS Commonwealth Lifesaving Championships in Windsor.
- Assisted Lifesaving Society Newfoundland and Labrador in obtaining and configuring new servers and network devices, improving inter-branch connectivity, collaboration, and performance.
- Improved on our internal cyber security practices, such as implementing multifactor authentication for our cloud infrastructure.
- Completed updates to the online leadership recertification feature to accommodate the point system launching in 2024.
- Made changes to the affiliate licensing and renewal system, improving our internal processes and refining our customer experience.
